

- Educational Commission for Foreign Medical Graduates (ECFMG)
- United States Medical Licensing Examination (USMLE)



USMLE

The United States Medical Licensing Examination

- Three-step examination for medical licensure in the United States
 - ST 1 sciences basic to the practice of medicine
 - ST 2 CK & CS clinical knowledge and clinical skills
 - ST 3 Foundations of Independent Practice (FIP) and Advanced Clinical Medicine (ACM) including computerbased case simulations (CCS)
- Eligibility for the USMLE Steps
 - US students > medical school
 - International students > ECFMG



ECFMG

Educational Commission for Foreign Medical Graduates

- Established in 1956 as a private, nonprofit organisation
- Headquartered in Philadelphia, Pennsylvania
- Employs more than 800 people
- Promotes quality health care (in the US)
- FAIMER, Foundation for Advancement of International Medical Education and Research



ECFMG (2)

Educational Commission for Foreign Medical Graduates

- 25% international MDs > ECFMG Certification
- Medical School Accreditation Requirement for ECFMG Certification: 2010 > 2024 (previously 2023)
- Medical student or MD of a medical school that is accredited by a QAA recognized by the WFME



WFME

World Federation for Medical Education

- Established in 1972 as a nonprofit organization by WHO, WMA (World Medical Association), ECFMG and IFMSA (International Federation of Medical Student Associations)
- Headquartered in Ferney-Voltaire, France
- Promotes high quality medical education worldwide

WFME Recognition

Accreditation

- Recognition of medical school accrediting agencies
 - a) Accreditation > QAA
 - b) Recognition > WFME
- Response to two major concerns
 - a) Growing market for accreditation
 - b) Rapid expansion in number of medical schools

- Global mark of quality
- Quality enhancement
- ECFMG eligibility



State of Affairs

- WFME recognised: 25
- Applications: 16

- Pandemic
 - On hold
 - Extension until 2024



Process

- 1. Preliminary discussions
- 2. Recognition submission
- 3. Appointment of team members
- 4. Submission of application
- 5. Final arrangements
- 6. The recognition assessment
- 7. The recognition report
- 8. The recognition decision
- 9. Follow up
