Pursuant to the provisions of Article 8 Paragraph 3 of the Act on Quality Assurance in Higher Education and Science (Official Gazette, 151/22) and the provisions of Article 32 Paragraph 1 Sub-paragraph 1 in relation to Sub- paragraph 11 of the Statute of the Agency for Science and Higher Education (CLASS: 003-05/13-01/0001; FILE NUMBER: 355-01-23-29) at its 22nd regular session, held on 10th April 2025, the Accreditation Council adopted the following

Quality Standards in the Procedure of Evaluation of the Research Institute Abroad

Article 1

(1) **Quality Standards in the Procedure of Evaluation of the Research Institute Abroad** shall include standards, elements and quality indicators against which the level of their fulfilment is determined and a quality grade is passed in the procedure of evaluation of the research institute abroad.

(2) For the purposes of this document the following expressions shall have the following meaning:

1. A **standard** is a clearly defined level of quality of a particular aspect of quality of a research institute. The quality standards are grouped into units (three assessment areas) content-wise and they refer to various aspects of quality evaluation of the research institute.

2. Elements of the standard are taken into account in the assessment of compliance of a quality aspect of a research institute against a standard.

3. Indicators are used to assess the level of compliance of the standards.

Sources for verifying fulfilment of the standard are documents of the research institute, the website of the research institute and other materials used to check and assess the level of fulfilment of the standards. The sources specified in this document are merely examples that a research institute can use as guidelines in the preparation of the request, as well as help to expert panels in assessing the level of fulfilment of quality standards.
5. The level of fulfilment of the standards is a quantitative grade and a qualitative assessment passed by an expert panel, which includes recommendations for quality improvement.

(3) Gendered terms used in this document are used neutrally and refer equally to all genders.

Article 2

In the procedure of evaluation of the research institute abroad, the following quality standards grouped into the following three assessment areas shall apply:
